



## RSPB Mid-Nene Local Group 2025 Calendar Photography Competition rules

The theme for Mid-Nene Local Group Photography Competition 2024 is “**British Wildlife**”. The theme is open to your personal interpretation but we are looking for beautiful images of British wild mammals, birds, reptiles, amphibians, invertebrates, plants or fungi. Images of domestic pets, farm animals and animals in captivity are not eligible.

The twelve images selected by the judges will appear in the Mid-Nene Calendar for 2025 sold in aid of the RSPB Mid-Nene Local Group to raise funds for RSPB conservation projects.

### How to Enter

1. Please read rules below.
2. Entrants may submit no more than **THREE** images. Entries must be in digital format. Prints cannot be accepted.
3. Only entries in .jpg format will be accepted. The images should be clear and sharp as they will be printed up to A4 size in the calendar. Successful entrants may be asked to submit higher resolution files for final judging.
4. Entrants should be aware that images in **landscape format** will be required for the calendar.

6. Entries **must** be submitted via e-mail. No other means of entry will be accepted. Send your completed entry form and images to [midnenephoto@gmail.com](mailto:midnenephoto@gmail.com).
7. All entries must be submitted by **31 January 2024**. Late entries will not be accepted.

### Rules

- The competition is open to **members of the Mid-Nene Local Group only**.
- Pictures must be taken in the United Kingdom.
- Amateur photographers only.
- Any RSPB employee or their immediate family will be ineligible to enter.
- No wildlife or habitats should be harmed, put at risk, or unduly disturbed in the process of taking photographs. Further guidance is available at: <https://rps.org/media/1xcnsuga/the-nature-photographers-code-of-practice.pdf>.
- Full copyright title remains with the owner. Please see full terms below regarding your entry and its potential use.
- If your entries contain **recognisable people**, you must obtain their written permission for their image to be entered into the competition using the attached Photography Permission Form.
- Entrants under 18 must have parental or legal guardian consent prior to entering the competition.
- The RSPB Mid-Nene Local Group accepts no responsibility for entries which are lost or corrupted during upload.
- Entries will be judged by members of the Mid-Nene Local Group at the indoor meeting held either in the Saxon Hall, Raunds on the 21 March 2024.
- In the event of a chosen image being unsuitable for printing up to A4 size for the calendar, the competition organisers will select another image, from the runners up, to replace it.
- The Mid-Nene Local Group cannot judge any pictures whose details have been entered incorrectly.
- The competition organisers' decision on all matters affecting this competition is final and legally binding.
- No correspondence regarding the results will be entered into.
- Winning entrants will be notified by email and a list of the names of the winning entrants, along with the title of their winning submissions, will be posted on the RSPB Mid-Nene Local Group
